FINANCIAL AID APPLICATION

Please be advised of the following procedures to apply for a tuition scholarship:

- 1) All scholarship applications should be emailed to office@moshava.org. No scholarship application will be considered without a camper application and a \$1,000 deposit per camper. If awarded a scholarship which does not meet your needs, the deposit minus a \$100.00 processing fee will be refunded upon withdrawal of your application in writing.
- 2) Scholarship applications are reviewed by our Scholarship Committee during monthly meetings from November March. **The deadline to apply is March 1.** You will be notified by email after the application is reviewed of the Committee's decision
- 3) Camp Moshava has a very limited Scholarship Fund. We strongly encourage and recommend that you apply for the Second Session if you are in need of a larger scholarship.
- 4) We recommend that you fill out this application completely AND attach a letter explaining clearly why you feel it is essential that Camp Moshava grant you a scholarship. We also recommend that the amount of your tuition subsidy request be accurate, NOT an inflated sum, in the hope that then you will receive what you actually need.
- 5) In cases of divorce, if both parents plan on submitting applications they MUST be submitted at the same time or at the very least coordinated, so we are aware in advance.
- 6) Please make a copy of your scholarship application and supporting materials.
